- **Dust Suppressant - Joint Tender:** Attached is the results of the Dust Suppressant – Joint Tender. Four companies bid on this contract
Recommendation: Staff recommends Council to award the tender to lowest bidder Les Enterprise Bourget Inc. Their storage depot is located in Cornwall. By accepting the lowest bidder would mean a saving of approximately \$27,000.00 for the Township in comparison to last year's prices.
 - **Hill 70 Signs:** I was approached by the Mountain Lions Club for permission to install Hill 70 Signs on Clark Rd to indicate to the public where Hill 70 is located. The Lions Club also approached the County on installing signs on County Rd 1. The County replied to the Lions Club that they would not allow them to install signs on County Rd 1 unless the Township assumes responsibility for the signs. All signs and installation is at the Lions Club expense. Staff recommends that Council assume responsibility for the signs on County Rd #1.
 - **York St:** Winchester Public school asked if the Township would allow them to close York St for their Carnival day on June 12, 2014 from 3:00 pm to 7:00 pm. I recommend to Council to allow them to close York St for that date and time. The Township will notify emergency services.

- **Hyndman Rd:** We have a budgeted amount of \$269,000 for base construction and \$136,000 for Surface Treatment for a total of \$405000. From past experience I would prefer preparing the base in 2014 and surface treat in 2015. We could transfer \$136,000 from Surface Treatment to Unspecified Rd and use it to prepare more Rd.
- **April Floods:** The quick thaw at the beginning of April caused some major flooding throughout the Township. We were very fortunate to pull through with minor damage. We had 5 roads that were closed for a period of 6 days due to flooding.
- **Roads Department:** The Township crew have been busy repairing flooded roads, replacing two culverts on Van Camp Rd, cold patching, grading the gravel on a daily basis, repairing Rd signs etc...
- **Road Construction:** Attached is a list of road construction and resurfacing for Council's review.
- **Monthly Activities:** Meet with planning on numerous projects.
