WM – Waste Collection Contract: Director of Waste Management Froats provided key information regarding the waste collection contract. He recommended the contract be extended for a 5 year term. Council concurred with the recommendation. The agreement will be presented at the December 13th meeting.

PBB – Development Charges Background Report: Director of Planning Pol provided key information relating to the Report and Development Charges Act, and outlined the process required to adopt a Development Charge By-law, noting the current DCB 5-2012, passed on January 24, 2012 will remain in effect until January 24, 2017. Upon completion of the Development Charges Background Study presentation, Council requested an allocation from the fire station to sidewalks, and that the change be included in the final draft by-law. The statutory public meeting will be held on January 10, 2017 with final passage of the Development Charges By-law scheduled for January 17, 2017.

CAO – Recruitment of Economic Development Officer: CAO Rutley advised over 40 resumes have been received for the position. She asked who would represent Council on the hiring committee. Mayor Duncan and Councillor Fraser agreed to serve on the committee.
