## iii) Cannabis for Personal Medical Purposes - Municipal Consultation

Resolution No. 010 Moved by Councillor Thompson Seconded by Councillor Armstrong

Whereas Health Canada issues registration certificates to individuals to produce cannabis for medical purposes under the Access to Cannabis for Medical Purposes Regulations (ACMPR); AND Whereas when applying to be a licensed producer under the ACMPR, or when applying to amend a license, an applicant must notify the municipality, local fire officials and local law enforcement; And Whereas there is no process to ensure that these notifications have taken place; And Whereas in Ontario, according to the Building Code Act, municipalities are charged with the responsibility of ensuring safe buildings; And whereas according to the Municipal Act, 2001, S.O. 2001, c. 25 s. 447.2, municipalities are specifically charged with responsibility for inspection of buildings containing marijuana grow operations in order to make the building safe and otherwise protect the public; And Whereas Cannabis production may require building modifications to ensure healthy air quality for the inhabitants and to prevent building deterioration; Now Therefore be it resolved that the Township of North Dundas lobby Health Canada for mandatory consultation with municipalities prior to and after issuing licenses to produce cannabis, and that this notification is a mandatory part of the approval process instead of the current practice whereby the applicant is responsible for notification and no verification that this has been completed is required; And Further, that this resolution be circulated to our MP, MPP, EOWC, AMO and all Ontario municipalities for support by lobbying their respective MP.
