The Contractor has carefully examined the provisions, plans, specifications and conditions attached to this tender and has carefully examined the site and location of the work to be done under this contract, and the Contractor understands and accepts the said provisions, plans, specifications and conditions and, for the prices set forth in this tender, hereby offers to furnish all machinery, tools, apparatus and other means of construction, furnish all materials, except as otherwise specified in the contract, and to complete the work in strict accordance with the provisions, plans, specifications and conditions attached to this tender.

Tenders shall be open for acceptance for a period of 30 days after the closing date. After this time, the tender may only be accepted with the consent of the successful bidder.

Notification of Acceptance shall be made by prepaid first class mail, addressed to the Contractor at the address contained in the tender and upon such notification of acceptance the within tender shall constitute the contract between the parties. Therefore, no agreement for or other separate document will be required.

It is agreed that the tender quantities are estimated only and may be increased or decreased by the municipality without alteration of the contract price. However, should such increase or decrease exceed 20%, then either party to the contract may request, in writing, that negotiations be carried out to determine if a revised unit price would be appropriate.



INFORMATION TO BIDDERS

Basis of Rejection of Tender

Tenders may be rejected for any one of the following reasons:

- (a) Bids received after closing date.
- (b) Bids received on other than the tender form supplied.
- (c) Bids not completed in ink or by typewriter.
- (d) All items not bid (except where tender form clearly states that award may be made for individual items).
- (e) Qualified or conditional bids.
- (f) Bids not properly signed and sealed.
- (g) Bids not received in a sealed envelope.

Liability Insurance

The Contractor shall take out and keep in force until the date of acceptance of the entire work by the municipality, a comprehensive policy of public liability and property damage insurance acceptable to the municipality providing insurance coverage in respect of any one accident to the limit of at least \$5,000,000.00, exclusive of interest and cost, against loss or damage resulting from bodily injury to or death of, one or more persons and loss of or damage to property and such policy shall name the municipality as an additional insured there under and shall protect the municipality against all claims for all damage or injury including death to any person or persons and for damage to any property of the municipality or any other public or private property resulting from or arising out of any act of omission on the part of the Contractor or any of his servants or agents during the execution of the contract and the Contractor shall forward a certified copy of the policy or certificate thereof to the municipality before the work is started.

The Contractor must be accountable for all health and safety infractions that his or her company's employees commit.

Regulations

The Contractor shall abide, if applicable, by the requirements of the Industrial Standards Act, the Employment Standards Act and any other Acts or By-Laws which are relative to the performance of the work.

Completion

All Surface Treated Roads will need to be completed by May 31, 2018 (Belanger, Nesbit and Van Camp Rd)

Time shall be of the essence of this agreement.



Payments

Monthly payments for work done may be paid up to 85% of the estimated value of the work performed; after 37 days of the date of acceptance of the completed contract, the remaining balance will be released to the Contractor.

Director of Public Works

Means the Director of Public Works of the Municipality or such other person, partnership or corporation as may be authorized by the Director of Public Works to act in their behalf in any particular capacity.

Damage by Vehicles and Other Equipment

If at any time, in the opinion of the Director of Public Works, damage is being done or is likely to be done to any highway or any improvement thereon by the Contractor's vehicles or other equipment whether licensed or unlicensed, the Contractor shall, on the direction of the Director of Public Works and at the Contractor's own expense make changes in or substitutions for such vehicles or other equipment or shall alter loadings or shall in some other manner remove the cause of such damage to the satisfaction of the Director of Public Works.

Supervision

All work to be done to satisfaction of the Director of Public Works.
